a.	Designed to give students interested in a medical field with an additional option. This track is a 3+1. Three years at Kutztown and one year at a Kutztown University affiliated hospital for clinical work.
2. LAS 2	Criminal Justice Accelerated 4+1 Program, Fall 2025
a.	This creates a clearly articulated path for students interested in completing both the B.S. Criminal Justice and Master of Public Administration: Criminal Justice in five years. Accomplished by students taking four graduate level courses as part of the undergraduate curriculum. Student will complete all requirements of both programs including counting 120 credits toward the bachelors degree and 36 credits toward the masters degree.
3. LAS 2	New Program: Biotechnology Certificate, Fall 2025 This certificate program is designed to develop and enhance practical workplace skills for current and future workers in the biotechnology and pharmaceutical
